

Matthew Reynolds Personal Use Font License

This is an end user license agreement (EULA). It explains what you may and may not do with the font software you downloaded from Matthew Reynolds. By installing or using the font software, you're agreeing to this EULA.

What you may do

You may install the font software

You may install the font software on any computer you own anywhere in the world, as long as it does not allow the software to be downloaded over the internet by others or used locally by more than five (5) users.

Personal use is allowed

You may use the font software for personal use only. Commercial use requires a separate license and fee – please email fonts@matthew.re.

(If you're using the font at home for fun or to make Etsy products, that's considered personal use. If you want to use it for a business where you are **not** the only employee, that's considered commercial use.)

If you use the font software in any work that contains a colophon or credits, you agree to list Matthew Reynolds as the creator of the font software and include a link to https://matthew.re/ynolds/fonts or the font's microsite.

You may sell letterform-based products

If you want to make stickers, house numbers, T-shirts, or other physical products from the glyphs contained in the font software, you may.

You are also allowed to sell these kinds of products, as long as the product description lists Matthew Reynolds as the creator of the font software and includes a link to https://matthew.re/ynolds/fonts or the font's microsite.

What you may not do

You may not modify the font software

No part of the font software may be edited, changed, disassembled, or reverse engineered.

You may not convert the font software into a different format, but WOFF2-type files are available with a separate license and fee.

You may use and modify glyphs from the font software inside of a graphics editing program, but you may not create new font software from them.

You may not redistribute or sell the font software

This EULA only allows **you** to use the font software. It doesn't allow you to give or sell the software to someone else and can't be transferred to them. Please instead send them a link to https://matthew.re/ynolds/fonts or the font software's microsite so they can download the latest version directly.

You may not embed or convert the font software

This Personal Use License does not allow for the font software to be embedded in any application or website or to be converted to any other format than the one supplied.

WOFF2-type files are available for use on websites with a separate license and fee by emailing fonts@matthew.re. OTF-type files aren't allowed to be hosted.

You may not remove credit

You may not change or remove any copyrights, web addresses, or names of the font software or its creator from the original font software.

You may not use the font software to do harm

The font software may not be used in any context that spreads violence, warmongering, racism, xenophobia, sexism, biphobia, homophobia, transphobia, or any other form of discrimination or hatred.

The font software may not be used in any context that promotes non-renewable resources or actively works against nature conservation and the wellbeing of our planet. It's the only one we've got!

Updates

The font software may be updated occasionally, fixing bugs or tweaking design. These updates are not guaranteed.

Any update will be free of charge and will include its own EULA. This EULA only applies to the version of the font software it accompanies.

Major releases or additional font weights are not considered updates and may have an additional cost.

Copyright and ownership

The font software is made up of code and glyphs. Matthew Reynolds is the creator of those glyphs and the code behind them and is the only owner of their copyright. This license gives you permission to use the font software, but it doesn't give you ownership of the copyright.

The font software may contain content that is copyrighted by a third party. They remain the owner of that copyright. Matthew Reynolds doesn't own it.

Warranty

The font software is a work in progress and is provided "asis." Substantial effort has gone into making this a quality product, but flaws or bugs may exist. Matthew Reynolds does not make any promises about the font software and is not required to fix any problems with it or that result from using it. No refunds or other compensation will be given.

Liability

Matthew Reynolds is not liable for any damage or problem that results from downloading or using the font software and is not responsible for any third-party claims against you.

This EULA is governed by Florida and United States law. Any action or proceeding regarding the font software or this EULA must take place in Orange County, Florida.
